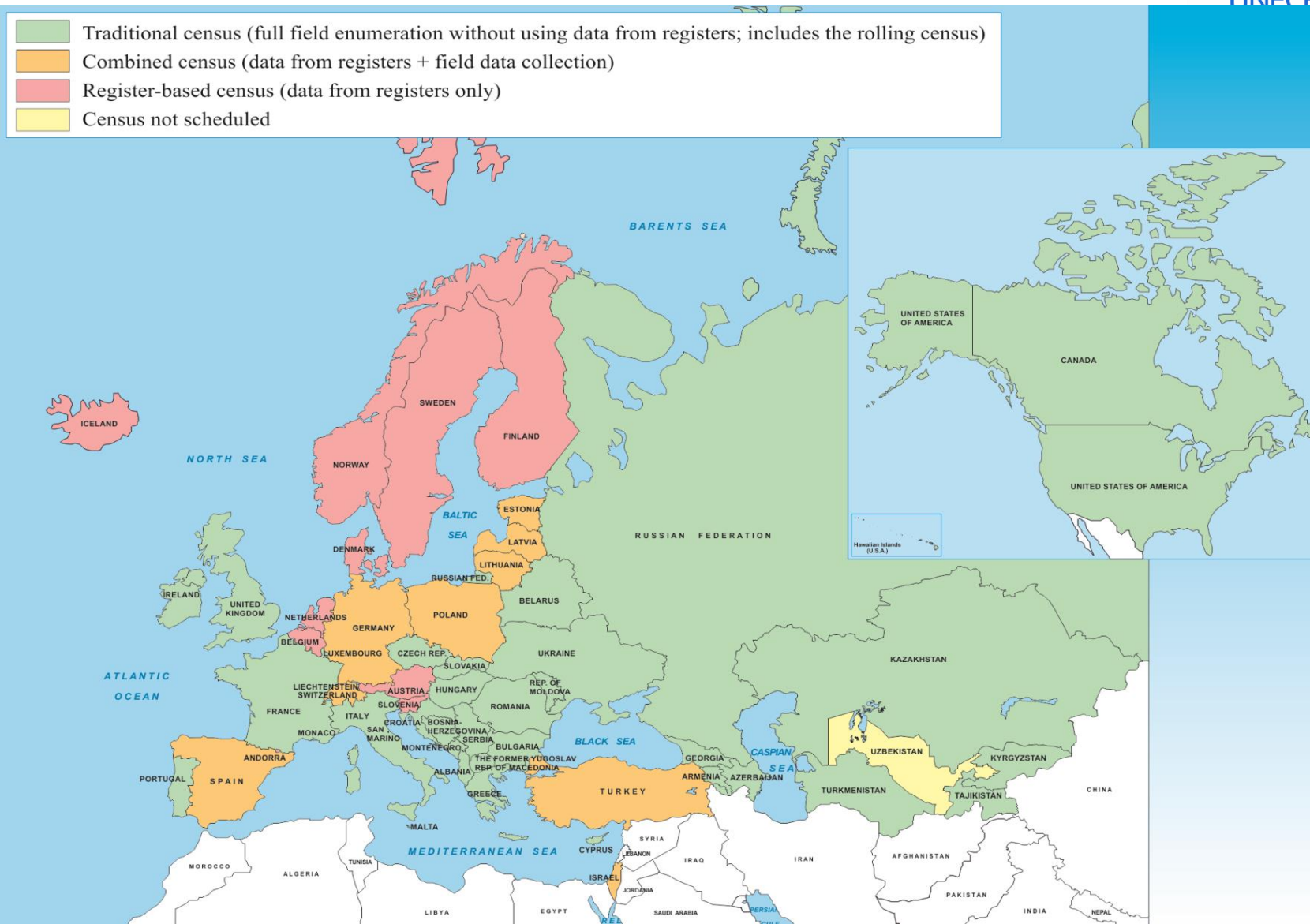
Census methods - definitions

- ❖ **Traditional**: Full field enumeration with paper or electronic questionnaires, and/or internet response (includes rolling census)
- ❖ **Combined**: Data partly taken from administrative registers + limited field data collection
- ❖ **Register-based**: Data taken from administrative registers (and possibly from existing surveys) – No field data collection

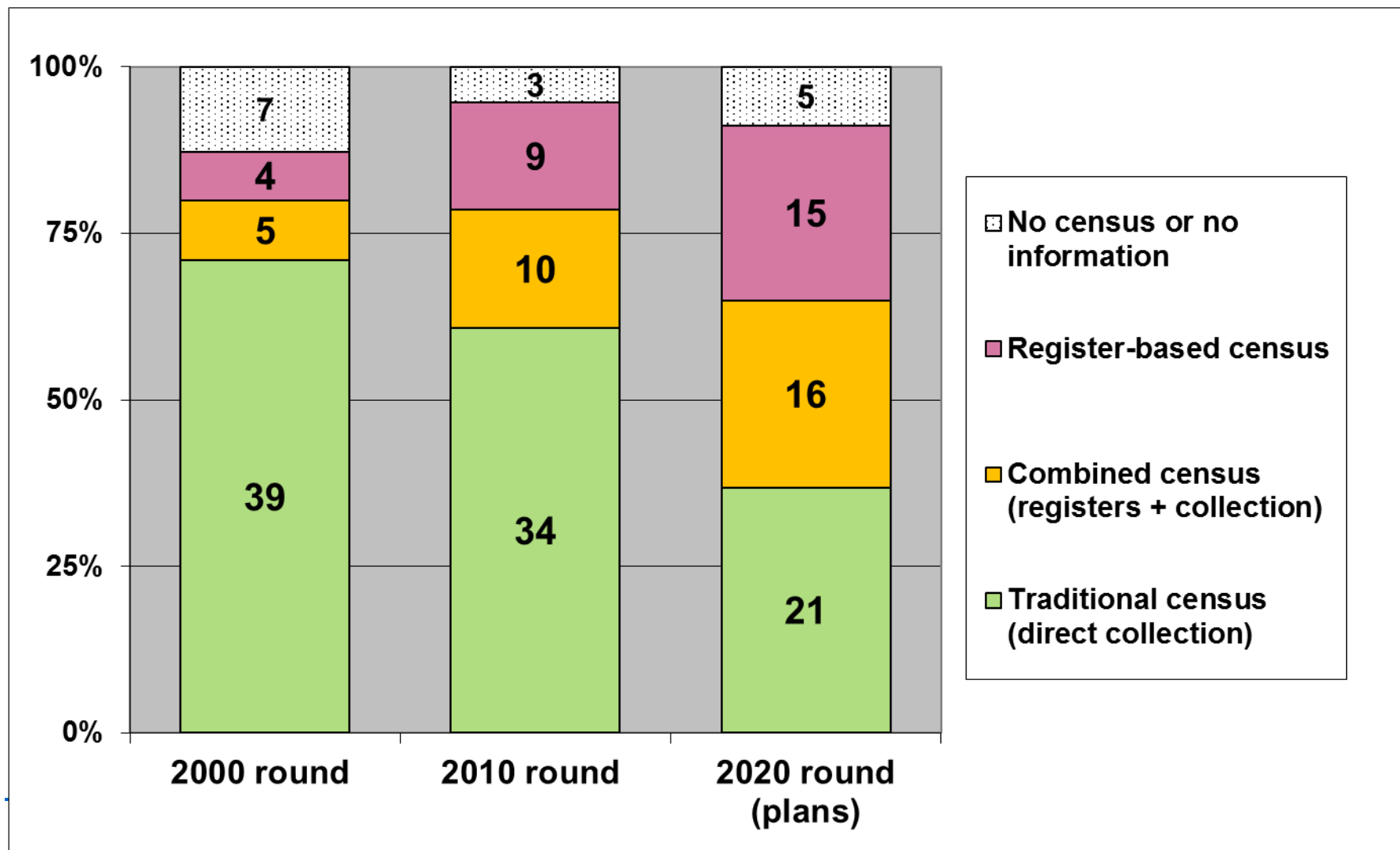
Map of UNECE countries by census method used in 2010 round



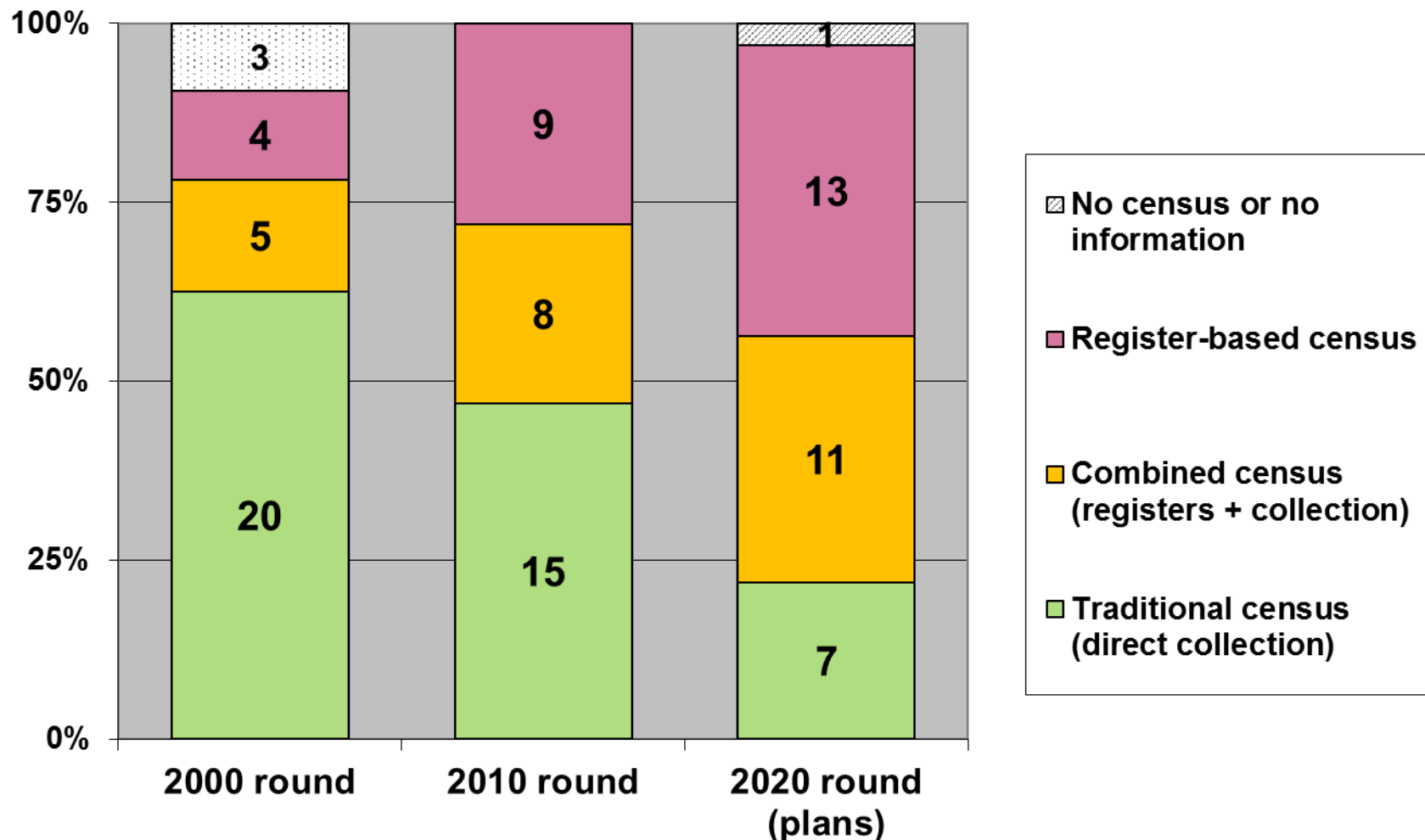

Number of UNECE countries by census method 2000, 2010, 2020 (plans) census rounds

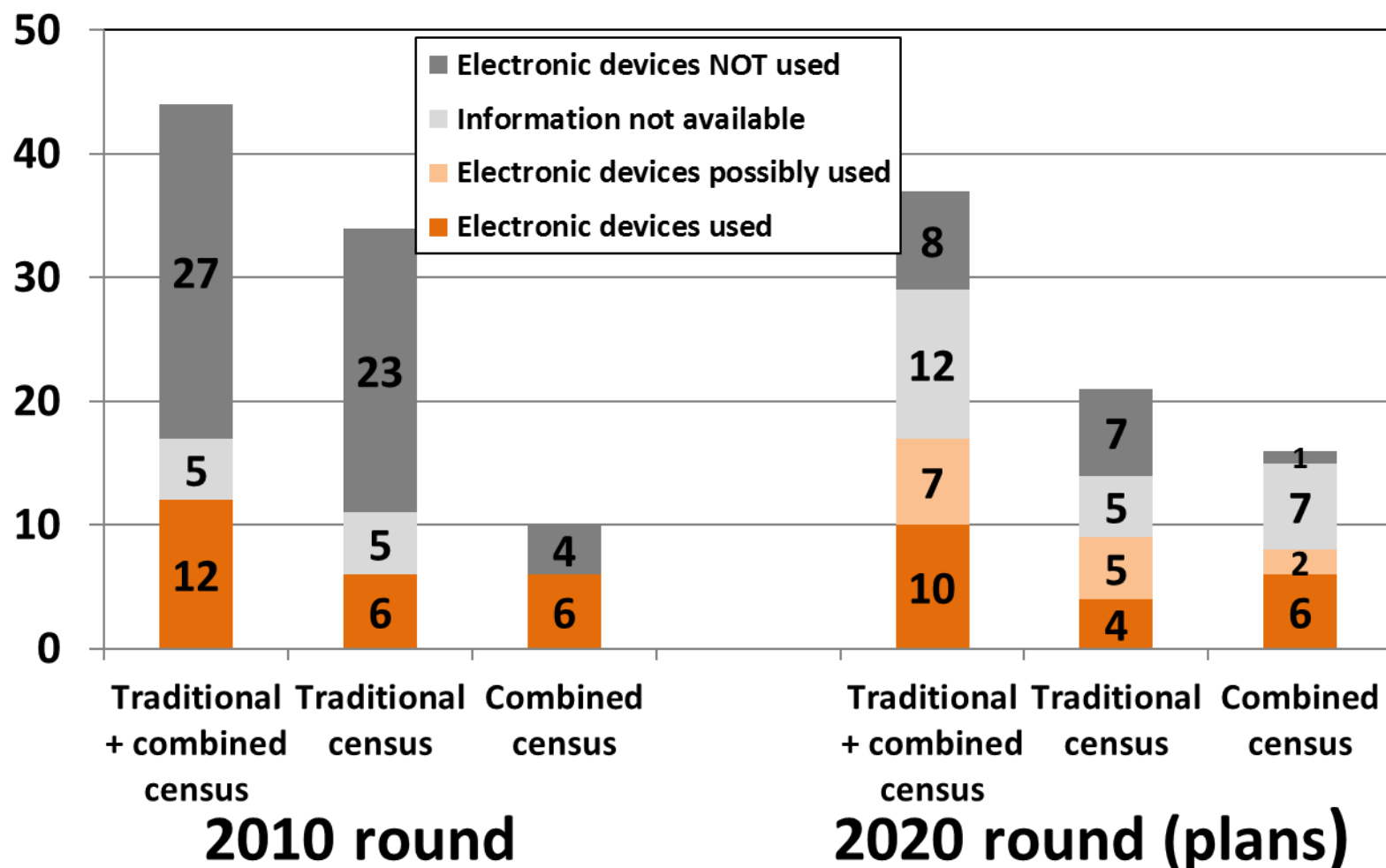


Number of **EU+EFTA** countries by census method 2000, 2010, 2020 (plans) census rounds

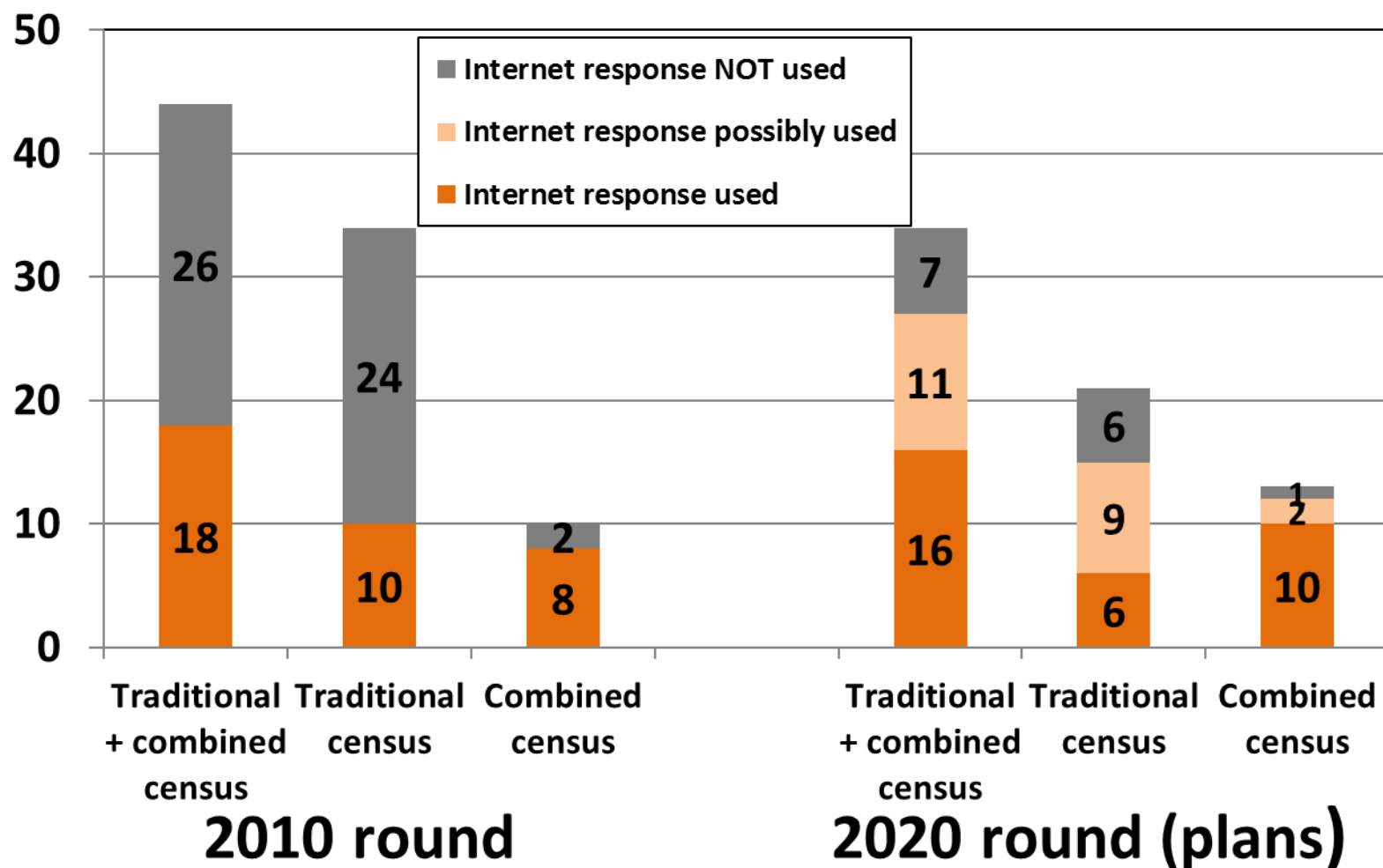
Number of UNECE countries using devices (laptop, tablet, hand-held devices, smartphones) for data collection

Number of UNECE countries using internet response

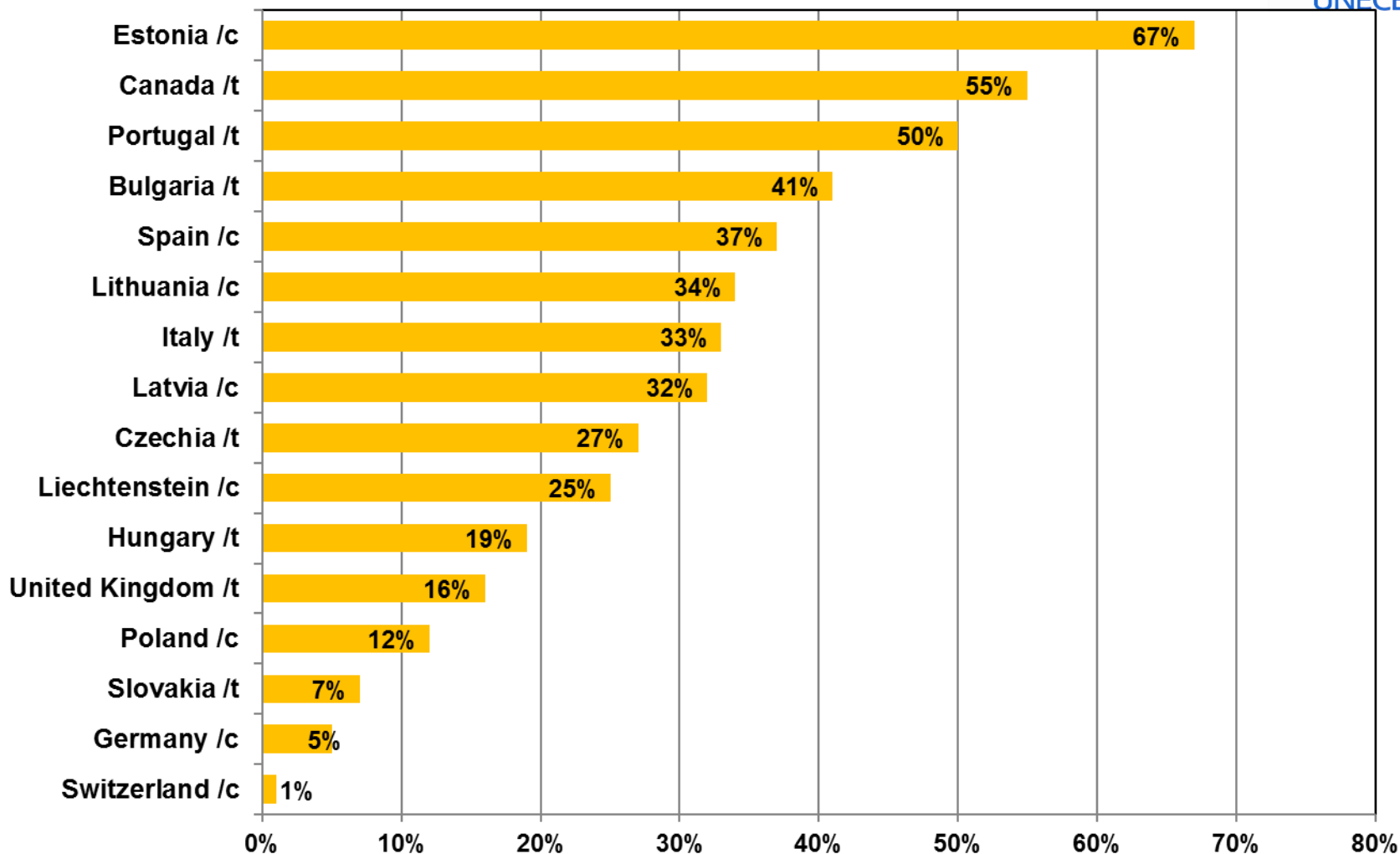

Take-up rates in UNECE countries, 2010 round

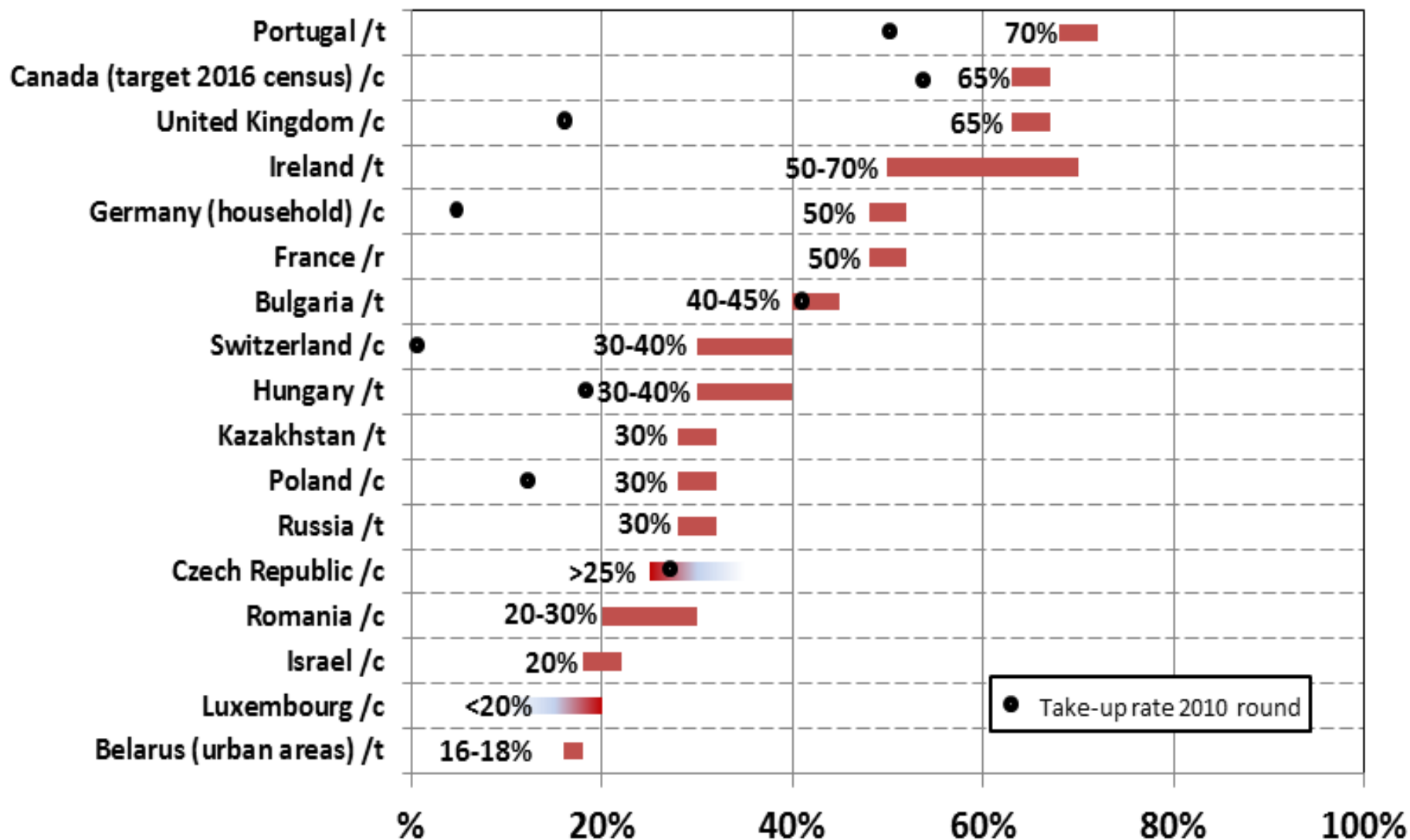

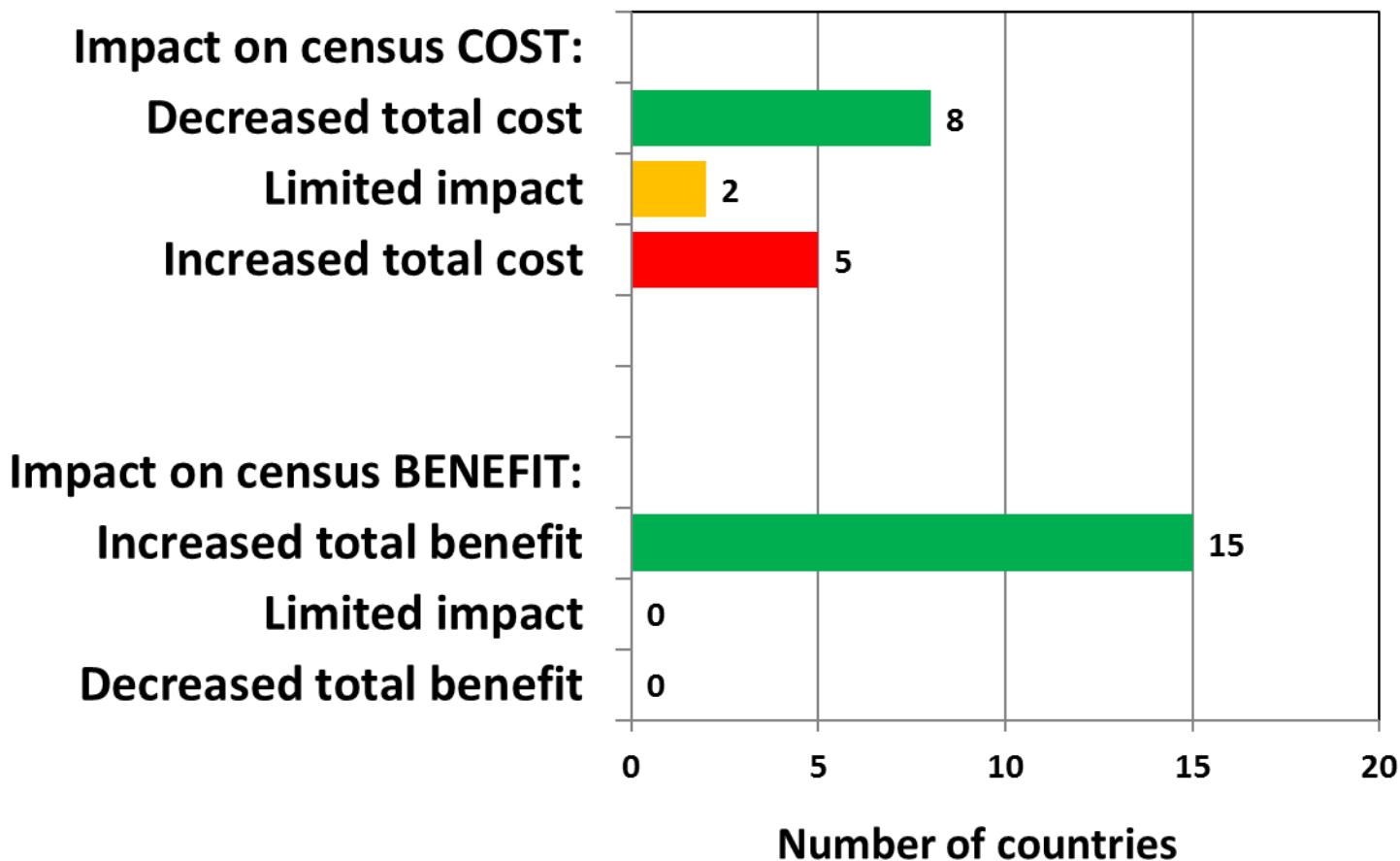

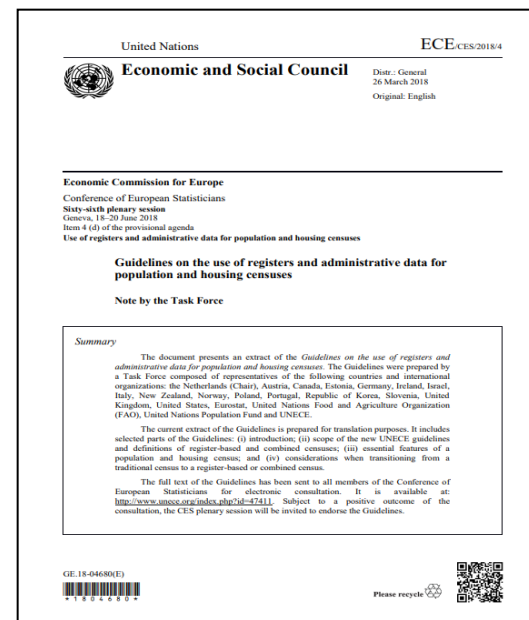
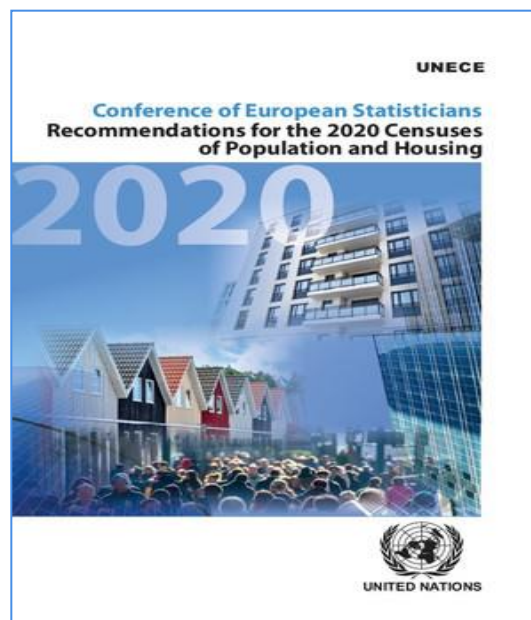
Impact on total census cost and benefit – 2010 round



Final comments

- ❖ Countries increasingly adopt **alternative census methods and new technology**, to reduce costs, increase efficiency and provide more frequent and better quality results
- ❖ Innovations do not always result in cost savings, and **may carry some risks!**
- ❖ All innovations must be **carefully evaluated and tested well in advance**, to minimize the risks
